Tip Sheet from Cairns OT to NDIS referrers / participants

October 2024

We appreciate your referrals. We'd like to give you some extra info to help ensure you are referring participants who are within our scope and give us all the details we need to action your referral as quickly as we can.

Some participants' needs are **outside of our scope of practice** and we recommend other OTs for these services, unless they are specifically needing services that are within our areas of expertise listed below. Examples of participants who are not in our scope include children with developmental delay, children or adults with Autism / ASD / ADHD / mental health diagnoses / Intellectual Disability / Behavioural management issues, Assessments relating to SIL and SDA and Driving Assessments.

What / who is in our scope and expertise?

Adult / late teen participants with primarily physical disabilities who need OT.

We have expertise in the following areas:

- Hand, wrist and arm therapy, Splinting
- Chronic Swelling, wound and lymphoedema management
- Pain management therapy, especially Neuropathic Pain and Chronic pain
- Neurological / Cognitive rehabilitation
- Home modification and assistive technology prescription – **Limited availability from October 2024**

Referrals

Please send all referrals to referrals@cairnsot.com as this helps us to triage your referral and ensure the most appropriate OT sees each participant as soon as possible. We have provided our NDIS referral form in case you wish to use this, however you can use your own forms providing you provide all the details we need to action the referral, including:

- How the funding is managed and who the invoice needs to be emailed / submitted to
- The issues that the participant has and areas that you feel need addressing
- NDIS Plan and / or details from GP / Hospital / Rehab providers re medical diagnoses, details of their known functional issues
- Detail any timeframes that are important
- Clarify if a participant is urgent due to risk factors e.g. at risk of pressure injury / sudden deterioration / newly acquired disability vs they want things now

Our process

We would like to emphasise that as Occupational Therapists, we

- assess function and then we
- teach the appropriate task modification techniques / treat the condition to seek improvements
- prescribe and train the participant / carers with the appropriate assistive equipment
- recommend / design home modifications and liaise with the builders / contractors
- document the recommendations in the manner required by NDIS

There has to be a clinical need for the assistive equipment / home modification.

We cannot and will not 'rubber stamp' equipment / AT requests. Inappropriate or unnecessary equipment can be as dangerous as incorrectly prescribed medication and can reduce capacity.

Fees

Our fees are based on the number of hours we required for the assessment / treatment, documentation, travel and liaison. We will complete a service agreement with the participant or their advocate at or shortly after the initial assessment.

Our hourly rate is taken from the NDIS Price Guide. It is currently \$193.99 per hour GST Free. The hourly rate changes at least annually in line with the NDIS price guide.

We can treat self-managed and Plan Managed participants.

We are NOT currently able to see NDIA agency managed participants.
